Dear Mono Lake Friends,

We accomplished much for Mono Lake in 2006! In fact, working together, our successes reached far upstream from the lake to include the tributary creeks and surrounding lands as well.

Thank you for your personal involvement, your passionate letters, your financial contributions, and all that you do for Mono Lake. I hope you'll enjoy this brief report on the Committee. There's plenty more to be said, so please do contact me with any questions and suggestions you may have.

Here are some of our key 2006 achievements:

- Raising Mono Lake and restoring the ecological balance! Mono Lake rose 2.5 feet in 2006 thanks to a wet winter and the water rights victories we've won for the lake.
- Healing Mono's streams. In the wet spring of 2006 we saw peak stream flows accomplish significant restoration work on Rush Creek, thanks to the procedures and facilities we've worked on for years.
- Preserving clean air. When the federal Environmental Protection Agency proposed eliminating the clean air health standards that govern Mono Lake's toxic dust storms we responded. 2,500 member letters and a lot of legal work later, we got them to reverse course and retain the standards unchanged.
- Keeping Congressional protections intact. The Committee continued to work to stop a threatened 30-home subdivision on the western shore of the lake. The subdivision is clearly prohibited by federal law, but the developer has used loopholes to create a difficult situation; unfortunately the issue gained new momentum at year end.
- Stopping unwise land development. Despite what some reports have said, we know that Mono Lake and its surrounding lands are great the way they are—they are not ideal for subdividing for inappropriate overdevelopment.
- Pursuing new urban partnership opportunities. The progressive leadership in Los Angeles has signaled interest in improving the city's relationship with the Eastern Sierra, and we're putting our ideas on the table: permanently protect local City owned land from development and expand our education partnership with urban youth organizations.
- Enabling critical Mono Lake science research by housing and supporting over 20 Mono Basin biologists in our new Mono Basin Field Station.
- Sharing our passion for Mono Lake with the next generation. The Committee brought 20 urban groups, many from LA, to the Mono Basin for five-day explorations and watershed education.

Mono Lake continues to inspire and motivate all our work. Our dedicated staff excels at accomplishing whatever is required to protect this remarkable place and to share it with the next generation of Californians. Thank you again for everything you do for Mono Lake—be sure to stop by and say hello next time you are in Lee Vining!

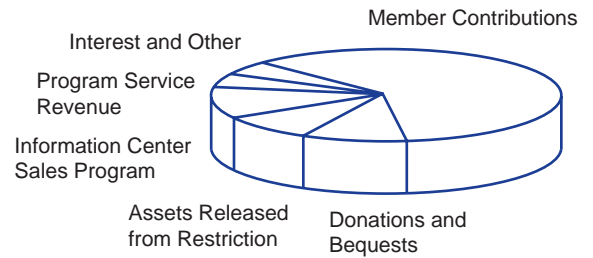

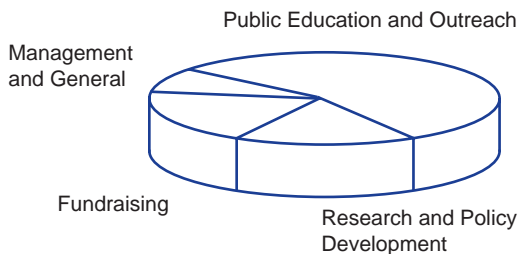

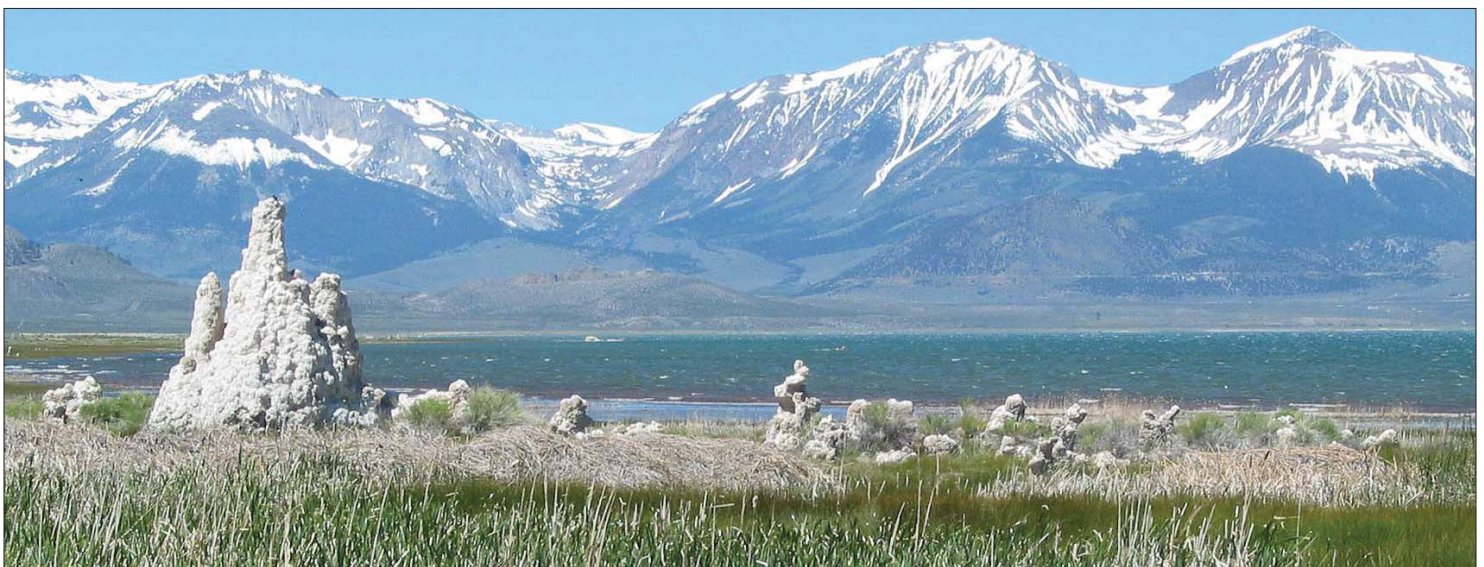

2006 Building Improvements

Since 1978 the Mono Lake Committee offices and Information Center & Bookstore have been housed in the former dance hall building in the heart of Lee Vining. Along with an original wood floor, quirky narrow hallways, and oddly-shaped rooms, the Committee inherited the building's old corrugated metal roof. No one quite remembers when the roof was last replaced, but after at least thirty years of bearing heavy winter snows and deflecting summer thundershowers, the roof was in dire need of replacement.

The fundraising effort for the roof generated a great response—thank you to the hundreds of members and friends who sent in donations! Along with funds for the roof we received letters and photographs of your Mono Lake memories for a time capsule placed in the new roof. Many moving stories of members' first visits to the lake, important family traditions in the Mono Basin, and hope for this place to remain unique and healthy for children and grandchildren are now tucked away for the next generation to find.

A roofing crew arrived in November of 2006 and worked quickly to strip away the old roof. Before the snow began to fall, the crew had a new waterproof roof installed (in just two days!), and Committee staff moved back into a building sheltered by strong corrugated metal in a lovely shade of Mono Lake blue.

Committee staff now enjoy working in a leak-free environment, and our computer equipment, valuable historic photographs, and new educational displays now stay safe and dry. Many thanks—we could not have done it without you!

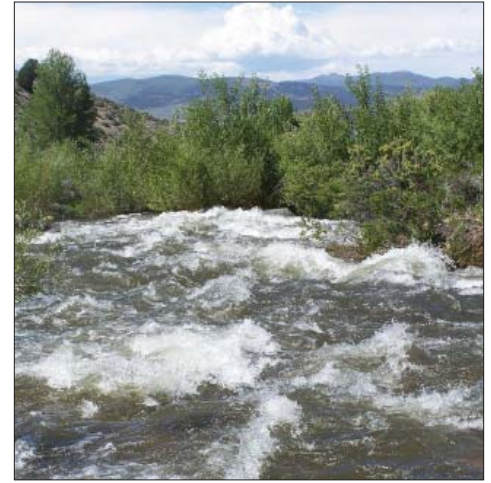
WATER

2006 was a record-setting runoff year for the Mono Basin, due to the extremely large snowpack. Mono Basin streams carried 165% of average runoff to Mono Lake, and the lake rose nearly three feet to a highstand of 6385.1 feet above sea level in August, a level not seen since 1972. This dramatic rise necessitated moving the South Tufa trail uphill ahead of the rising lake!

All of the creeks, with the exception of Parker Creek, peaked at higher flows than 2005. Grant Lake reservoir and Lundy Lake reservoir both spilled over their dams, and this large volume of water scoured the channels and moved large woody debris, significantly advancing habitat restoration.

AIR

The Mono Lake Committee responded quickly when the federal Environmental Protection Agency proposed doing away with federal air quality standards for windblown dust and “PM₁₀ particulate” dust in the Mono Basin in early 2006. The Committee mobilized local political leaders to object, launched a massive member letter-writing campaign producing over 2,500 comment letters to the EPA, and submitted a detailed 22-page legal brief. In addition, Mono Lake Committee members Gordon Matassa, Anna Mills, Kelly Runyon, and Diane Vornoli spoke on behalf of Mono Lake at a public hearing held in San Francisco.

Thanks to the action of Mono Lake Committee members, health departments across the country, and many congressional representatives, the EPA abandoned its plan to eliminate the threatened clean air health standards in September 2006! As a result, Mono Lake's toxic dust storms remain regulated, and the lake continues to rise.

LAND

In March 2005, Mammoth Mountain Ski Area purchased the 120-acre parcel on Mono Lake's west shore from the Cunningham family, intending to trade the land to the Forest Service for permanent protection. However, this purchase included a one-time buy back option for the Cunninghams, which they threatened to use on and off during 2006. During the summer their realtor posted “for sale” signs on the property even though they didn't own it! Then at year's end the option was triggered, resulting in the Cunninghams retaking ownership of the parcel in early 2007 and once again threatening a massive subdivision and resort home development. The Committee continues to advocate a land trade as the best resolution to this saga, but we also stand ready to go to court if need be.
